

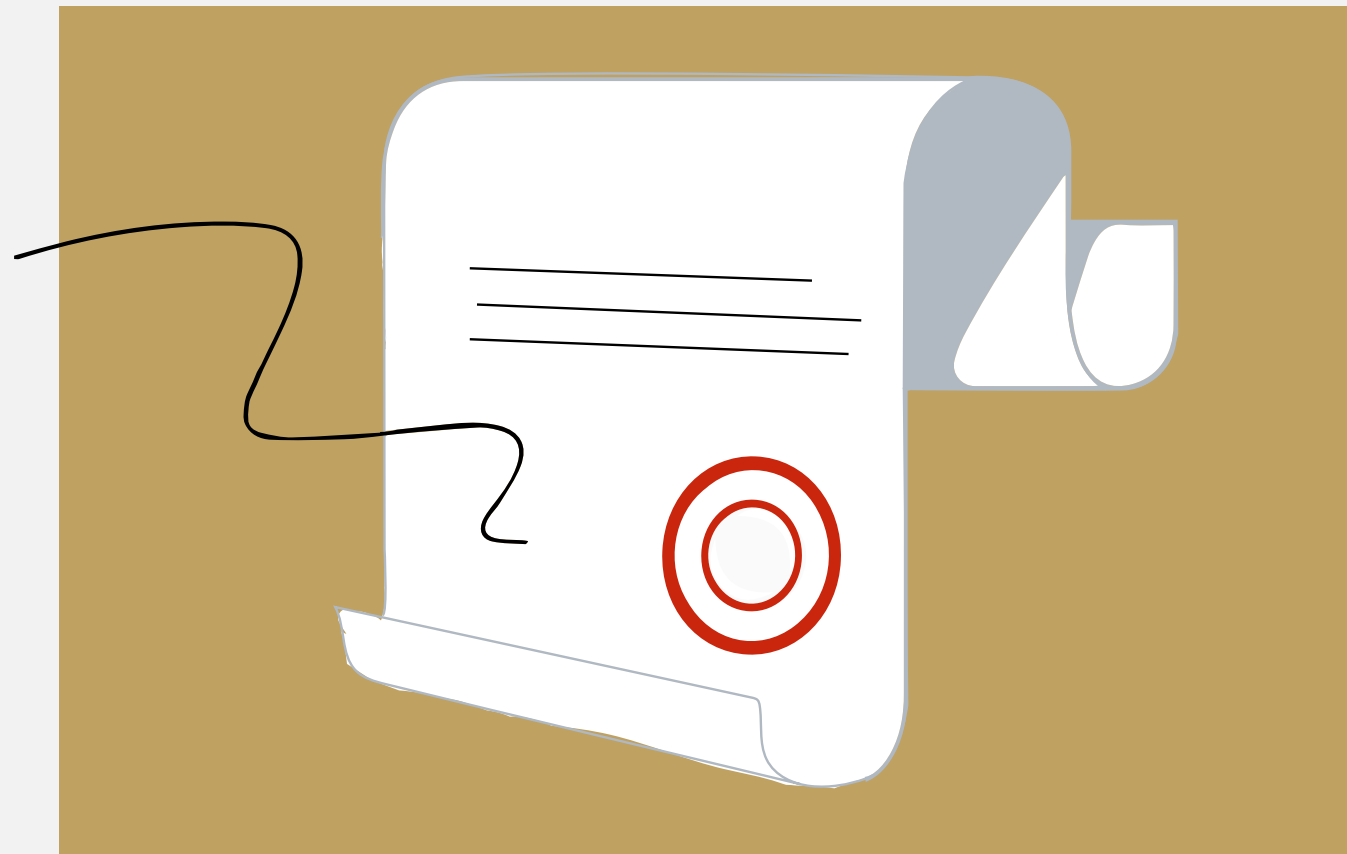

6 | Company Formation by Power of Attorney










A limited liability company (UAB) in Lithuania can be registered remotely. It is possible to create a company remotely by using a representative of **Company in Lithuania UAB**, who can act on your behalf by proxy.

SEQUENCE

- 1 Company in Lithuania UAB will send an example of power of attorney
- 2 Sworn translations into the state language, English and Lithuanian
- 3 Opening a preliminary account for capital contributions
- 4 Capital transfer into a temporary account of the company
- 5 Application to the Business Register
- 6 Once the company is registered, it will be possible to change the temporary bank account of the company to a permanent one.

Accounting is an obligatory requirement in the conduct of activities on behalf of a Lithuanian company, the purpose of which is to keep records and obtain an overview of the economic results and financial situation of the company.

All companies and subsidiaries of foreign companies operating in Lithuania are subject to accounting. The accounting of each company must conform to government-established standards so that the results are comparable and comprehensible.

Widely recognized in the traditional financial sector (FIAT) and in e-money licensing, the Lithuanian government also offers transparent and cost-effective virtual currency authorization.

10 | Payment Institution Licence in Lithuania



A licensed payment institution or payment service provider (PSP) in Lithuania is the most appropriate solution for financial service providers providing payment transactions and money transfers services.

SERVICES PROVIDED UNDER THE LICENCE:

- ✓ Cash deposit services in a payment account
- ✓ Cash withdrawal services
- ✓ Execution of payment transactions
- ✓ Directly debit execution
- ✓ Execution of credit transfers
- ✓ Carrying out payment transactions in which funds are covered by a credit line
- ✓ Performing Payment Transactions with a Payment Card
- ✓ Remittances

BASIC REQUIREMENTS

- ✓ The documents submitted must comply with the requirements of the legal acts regulating EMI activities and their supervision.
- ✓ The documents must comply with the requirements of legal acts regulating the activities of electronic money institutions.
- ✓ Compliance with the minimum statutory capital requirements for EMI: EMI must have paid the statutory capital of not less than 350,000 euros.
- ✓ The suitability and appropriateness of EMI and its shareholders or beneficiaries, having a significant stake in the charter capital of the payment institution and / or the right to vote, to be able to ensure the reliable and prudent management of the payment institution, have a good reputation and ensure the financial viability of the project.
- ✓ Suitability and integrity of the heads of the e-money institution.
- ✓ The business plan provided must correspond to the capacity of the EMI founders (shareholders or beneficiaries) to implement it, while the prospective payment institution must be ready to provide financial services at the time of the application.

The e-money institution is a market participant licensed by the Bank of Lithuania who has the right to issue electronic money.

STAGES OF APPLICATION:

- ① Application for the EMI license to the Supervisory Service of the Bank of Lithuania (five working days).
- ② Evaluation of the EMI license application and attached documents (within three months).
- ③ License or refusal to grant a license. The Board of the Bank of Lithuania analyses the submitted documents.
